

RESOLUTION 2020-10
APPOINTMENT OF ELECTION JUDGES FOR THE PRESIDENTIAL NOMINATING PRIMARY,
ANNUAL TOWNSHIP
ELECTION AND ESTABLISHMENT OF THE ABSENTEE BALLOT BOARD

WHEREAS, Watab Township Presidential Primary election on Tuesday, August 11, 2020,
at the Watab Township Hall between the hours of seven o'clock a.m. and
eight o'clock p.m.; and

WHEREAS, election judges must be appointed by the Township Board before
July 17, 2020; and

WHEREAS, all election judges must be trained and certified as official election
judges by the Minnesota Secretary of State;

NOW, THEREFORE, BE IT HEREBY RESOLVED that the following be named
as possible election judges for the annual election in Watab Township:
Clara Knettel, John Olson, Lucy Palmer, Donna Poganski, Sandy Rau, Joyce Segler, Julie
Johnson, Sheryl Weitgenant, Deborah O'Keefe, Gloria Nelson, Phyllis Post, Sandy
Saldana, and Kathy Sauer

WHEREAS, Watab Township is required by Minnesota Statute 203B.121, Subdivision 1
to establish an absentee ballot board before July 17, 2020; and

WHEREAS, this board will bring uniformity in the process of accepting or rejecting
returned absentee ballots in Watab Township; and

WHEREAS, the absentee ballot board would consist of a sufficient number of election
judges as provided in Sections 204B.19 and 204B.22;

NOW, THEREFORE BE IT HEREBY RESOLVED that the Watab Township Board
establishes an absentee ballot board that would consist of a sufficient number
of election judges as provided in Sections 204B.19 to 204B.22 to perform the
task including those judges listed in the above resolution appointing election
judges for the annual Township election.

WHEREAS, Watab Township will provide Election Judges for the Presidential Nomination
Primary, which will be held on August 11, 2020, at the Watab Township Hall between the hours
of seven o'clock a.m. and eight o'clock p.m.; and

WHEREAS, election judges must be appointed by the Township Board before
July 17, 2020 as required by Minnesota Statute 204B.21. Subdivision 2; and

WHEREAS, all election judges must be trained and certified as official election
judges by the Minnesota Secretary of State;

NOW, THEREFORE, BE IT HEREBY RESOLVED that the following be named
as possible Presidential Nomination Primary election judges:
